If you enjoy gentle, natural health therapies, Florida's Department of Health (DOH) believes you must receive them from a person licensed in a modality such as Medicine. These practitioners may have little or no experience in your chosen therapy.

This restriction violates your Constitutional right to choose the natural health therapies and practitioners that you decide are best for you. It violates your right to be free from unnecessary governmental intrusion into your private life.

Your support is vital!

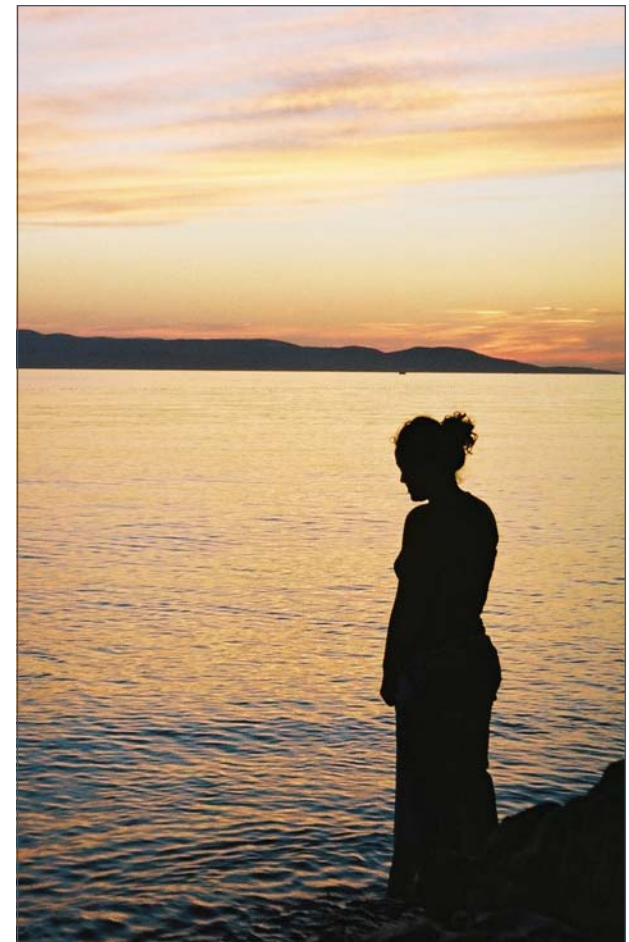

Health Freedom Now!

Did you know your right to receive natural health therapies from the practitioner of your choice is in serious jeopardy?

Your Constitutional right to choose therapies such as Reiki and Homeopathy from the practitioner that you want is being challenged.

The Problem

Natural health therapies involve gentle practices such as Reiki and Homeopathy. Florida's laws and Constitution are in conflict about whether the law limits your choice of practitioners for these gentle therapies.

Florida's Department of Health (DOH) regulates licensed health care professions. In the DOH's opinion, you must receive gentle, natural health therapies from people licensed in a profession such as Medicine. Because the state doesn't license the low and no-risk professions of Reiki and Homeopathy, and many others, the DOH's interpretation would effectively force you to use practitioners with little experience in the gentle therapies that you seek.

Florida Health Freedom Action (FHFA) is a non-profit organization dedicated to protecting your health freedom rights. In FHFA's opinion, the law limits your health care choices only when it's essential to protect you from a risk of significant harm. If this risk doesn't exist — as with gentle, natural health therapies — you are entitled to use the therapies and practitioners of your choice.

The Department of Health's interpretation ignores your Constitutional right to make personal health care choices of low and no-risk natural health therapies and practitioners without unnecessary state control.

The Solution

Florida's Legislature must declare that our laws protect your Constitutional Right to Choose the gentle, natural health therapies and practitioners that you decide are best for you.
